

## 2021 Self-Assessments



# Friendly Reminders for the start of 2022

### **Child-Related Activity Register submissions**

In June 2020 only 52 Parishes returned their Child-Related Activity Register, this year we had 105 Parishes submitted the Register. Just a friendly reminder that your Child-Related Activity Register will be due back for auditing in January 2022. Can you please send your register clearly labelled with the name of your Parish or Chaplaincy community to **ministry@sydneycatholic.org**, please contact the Safeguarding Office if you have any concerns or questions.

The Child Related Activity Register (Register) is an electronic tool to record details of the Working with Children Check and Safeguarding Induction and training details of Workers who are engaged in a Child-Related roles. The Worker can be a Volunteer or Employee. The Register assists the Parish Priest/Administrator to fulfil his legislative requirements applicable to both the *Children's Guardian Act* 2019 and the Child Protection (Working with Children) Act 2012.
